We attach great importance to the protection of your privacy, your data and the careful handling of your personal information. This privacy statement explains the type of personal information we collect, what it is used for, and your rights regarding the personal data you provide.

**When processing your personal data, we comply with the requirements set by law.**

## **What is Studio Dries Verhoeven?**

Studio Dries Verhoeven is the organization dedicated to producing and presenting work by artist Dries Verhoeven.

## **Why do we process personal data, and what type of data do we process?**

Studio Dries Verhoeven does not sell tickets and occasionally uses targeted promotional actions.

We use your name and email address for invitations and newsletters about future presentations of works and other news that we would like to share with you. These details are NAWE data that you probably provided to us yourself via our website, a registration form on Facebook or in some other way.

We use your data for market research, product and service development and other purposes related to general business operations.

Studio Dries Verhoeven makes visual material of performances and / or presentations. When filming output for promotional purposes, we announce this fact as clearly as possible. People not wishing to appear in the footage are taken into consideration. We do not give notice of photo or film shoots for the purpose of documenting the work. You may appear in our footage in an identifiable way. If you object, please let us know (see also: What are my rights?). We use visual material exclusively for informational and publicity purposes.

Sometimes, due to the nature of the work, we may not be able to seek your consent for publication. If you object to us using your image, please let us know (see also: What are my rights?).

## **How long do we retain personal data?**

We do not store your personal data longer than necessary. If you have indicated that you wish to receive newsletters or invitations from us via e-mail, we will retain your data until you unsubscribe. A standard unsubscribe link is included in our newsletters and invitations.

## **How do we protect personal data?**

We take suitable measures to prevent wrongful use, loss, unauthorized access, unwanted disclosure and unauthorized amendment.

## **Sharing personal data with third parties**

Studio Dries Verhoeven does not sell your information to third parties. We enter into a Processor Agreement with companies that process your details on our behalf to ensure the

same level of security and confidentiality of your data. Responsibility for the processing remains with Studio Dries Verhoeven.

**What are my rights?**

You have the right to ask us to give you access to your personal data and / or to correct, add, erase, or protect them. If you do not consent to the publication of photographic or visual material made by us, you can request us to remove the published material.
